Quantities in bid are anticipated requirements and are contingent upon availability of school funds.

Notations and Exceptions: AU 203A and AU-203B: Neff Company has requested withdrawal of their bid for these items for failure to meet specification for 10 or 11" inseam. Recommend acceptance of next low vendor.

AU305: Recommend rejection of this item for failure to receive any bids. Request permission to purchase on the open market after receiving written quotes.

AU-408C: Recommend rejection of this item. Item has been discontinued by manufacturer.
