Recommendation: Recommend acceptance of bids as noted on attached bid tabulation sheet as generating the highest revenue to the District.

Term of Contract The bid is for the disposal of twenty-six surplus buses for the Transportation Department.

Notations and Exceptions: Bid award was based on the highest per unit bid by bus capacity. Subsequent offers submitted were ranked and awarded based upon bid prices ranked from high to low (i.e. Taylor Bus Sales as highest bidder, Marketing Inc. second highest bidder, etc. for group I). Mathies & Sons Inc. declined the purchase of buses 707, 712, 714, 715, 716, 721, 726 and 793. These buses were awarded to the next highest bidder.

Recommend rejection of bid from Yellow School Bus Sales for failure to provide a certified or cashier's check. Recommend rejection of bid from Tampa Bus Makret, Inc. for failure to sign and return entire bid documents.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
