Recommendation: Recommend acceptance of bid as noted on the attached tabulation sheet for 145 Adobe CS3 licenses on behalf of the Community, Career and Technical Education Department for distribution to twelve (12) school sites.

Term of Contract: One-time purchase of licenses under District's licensing program with Adobe, through authorized resellers.

Notations and Exceptions: Bid from CCV Software was disqualified at the bid opening as they did not provide a signed bid sheet as mandated in the bid document. Tech Depot was disqualified at the bid opening as they did not provide a signed Addendum #1 as mandated in the bid document. As the CS3 version of Adobe is a very new release (Master Collection version is not available to ship until June 2007), bidders were unable to bid on an "apples to apples" basis for 2-year maintenance licenses. We therefore recommend acceptance of bid from Insight Public Sector for 145 licenses without maintenance, an option provided in the bid document, as lowest and best responsive, responsible bid meeting written specifications.

Offers from other vendors listed herein are the only offers received per the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
