Term of Contract: This RFP is for the purchase of athletic accident/injury insurance, for provision of non-duplicating coverage for all interscholastic athletic teams. The RFP is a three-year contract, with the first year at the above-referenced cost, with two (2) yearly renewals based on the mutual consent of the parties. The first-year term will be August 1, 2006 – July 31, 2007.
