Notations and Exceptions: Recommend acceptance of sole bid from ButterKrust Bakery. as lowest and best responsive bid meeting written specifications. Although we received only one bid for these services, research shows it is in line with historical prices.

Total savings was based on a comparison between other school districts Fresh Bakery Products bids.
