## **MEMORANDUM**

TO: Honorable School Board Members

RE: Supplemental Educational Services Contractual Agreements

Under the No Child Left Behind Act, Supplemental Educational Services (SES) must be offered to students at Title I schools. To comply with this requirement, the District's Department of Curriculum and Instructional Services sent packets to the providers who indicated they were interested in providing services for the District School Board of Pasco County.

The School District has numerous contractual agreements with various facilities in order to provide educational services for supplemental educational services. The attached agreements represent educational services between the District and the following: Knowledge Learning Corporation, ABC Educate Me, LLC, A+ Tutor U, Academic Consulting and Tutoring Services, LLC, Advanced Learning Centers, All Things Through Learning, AT's Project Success, Babbage Net School, Inc., BrainFuse, Bright Futures Learning, Inc., Byrnes ELC, LLC, Carter, Reedy & Assoc., Club Z! In-Home Tutoring Services, Cool Kids Learn, Education Station, LLC, Next Level Learning, Link-Systems International Inc., Read Right Systems, Inc., StudentNest.Com, and Sylvan Learning Center.

The above listed agreements require Board approval at this time. The final Per Pupil Allocation for SES is \$1,153.00 per student. There is an estimated 5,031 students that qualify for SES services. The number of estimated dollars to be used to pay each provider is \$45,000 for the 2006-2007 school year. The prices were negotiated and within the pricing structure set forth by the Florida Department of Education (i.e.\$5 and up to \$80 per student, per hour). The vendors selected were recommended via the Department of Education (see attached).

Under the Department of Education Rule 6A-1.012(7), the District is exempt from the bid process for the purchase of professional or educational services. At this time, it is my recommendation to approve the dollar expenditures to the approved DOE vendors as noted on the attached requisitions and contracts.
