Recommendation: Recommend acceptance of Request for Proposal per the attached tabulation. Per the terms of the RFP, acceptance of the three (3) short-listed firms, #1 Walbridge-Aldinger, #2 Creative Contractors, and #3 Greater Bay Construction, will enable New Construction to negotiate with the top-ranked firm in accordance with provisions outlined in RFQ 07-037-AZ and F.S. 287.055. If negotiations with the #1 firm are not successful, we have the ability to negotiate, in turn, with the 2nd and 3rd-ranked firms, and are requesting permission to do so should the need arise.

<u>Term of Contract</u>: Individual contracts will be negotiated by the New Construction Department to accommodate new school construction for openings currently scheduled through 2010. Prior to any work by a recommended vendor the contract, based on the current AIA document, will be submitted for approval to the School Board in governance at that time.

Notations and Exceptions: Package #1 consists of two (2) schools: Middle "FF" and Elementary "Q." Twelve (12) firms short-listed from RFQ 07-037-AZ, Board approved November 7, 2006, were interviewed and ranked by the Evaluation Committee on November 13 – 14, 2006. Based upon that ranking, the top five (5) firms were offered their choice of new school construction packages, according to the guidelines outlined in the RFP and RFQ 07-037-AZ. Per the award criteria in these documents, once a construction manager was chosen for a package, they were not eligible to be ranked #1 on any other package.
