**Recommendation:**

Recommend acceptance of bids as noted on attached bid tabulation as lowest and best bids meeting written specifications.

**Term of Contract:** This bid is for USDA Commodity Beef Processing for Food and Nutrition Services for use throughout the District and on behalf of the P.O.W.E.R. Buying Group to provide processing of USDA Commodity Foods, which consist of 25 surrounding Counties. This is the first year of a three year bid, renewable annually by written consent of both parties. The first year of the contract is effective January 23, 2008 through January 22, 2009.
