**Recommendation:** Recommend acceptance of bids as noted on the attached tabulation sheet.

**Term of Contract:** This is the first year of a three-year contract, renewable annually by mutual agreement of all parties. This contract will commence on February 6, 2005 and expire on February 5, 2006.

<u>Notations and Exceptions:</u> This bid was designed as a multi-awarded bid with up to three vendors for incidental novelty items. Estimated yearly expenditures for this contract are \$25,000.

Discounts will remain the same; however, vendors may update catalogs on a semi-annual basis.

Bids were awarded on a weighted point system: Discount/Net Costs (9pts.); Inventory (4pts.); Location (3pts.); and Past Service (2pts.). Bids from ABC School Supply, Childcraft, Authentic Promotions, Hammond & Stephens, Highsmith, Kaplan Early Learning, Lakeshore Learning Materials, Nienhuis Montessouri, Renaissance Learning, S & S Worldwide, School Specialty and Teacher's Discovery could not be considered as vendors did not have sufficient incidental novelty items listed in catalogs to meet the District's requirements.

Offers from the vendors listed herein are the only offers received as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
