Recommendation: Recommend acceptance of bids as noted on the attached tabulation sheet.

<u>Term of Contract:</u> This is the first year of a three-year contract, renewable annually by mutual agreement of all parties for math equipment and supplies. The first year of the contract will commence on February 6, 2005 and expire on February 5, 2006.

Notations and Exceptions: This was designed as a multi-awarded bid to a maximum of three vendors for general health supplies on an "As Needed" basis. Estimated annual expenditures for this contract are \$25,000.

Discounts will remain the same throughout the contract period; however, vendors may update catalogs on a semi-annual basis.

Bids were awarded on a weighted point system: Discount/Net Costs (9 pts.); Inventory (4 pts.); Location (3 pts.); and Past Service (2 pts.). Bids from Capital Microscopes Services, Kentron Health Care, Laerdal, Safety Products, School Specialty, W. W. Grainger, Ward's Natural Science and Zoll could not be considered as vendors did not have sufficient types of supplies listed in their catalogs to meet the District's requirements.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
