Recommendation: Recommend acceptance of bids as noted on the attached tabulation sheets, for the warehouse and for Veterans Elementary School and Crews Lake Middle School currently under construction.

Term of Contract: Part A: For a period of one (1) year from date of award. Part B (manufacturer's discount off list price): For a period of one (1) year from date of award, with two (2) consecutive yearly renewals at the mutual consent of the parties.

Notations and Exceptions:

Part A: Each Award Group was awarded "all or none" for compatibility of product. The bid from School Specialty was disqualified at the bid opening for failure to provide a mandatory bid bond.

Award Group #1: Student furniture & activity tables: Recommend acceptance of bid from Schoolhouse Products as lowest and best responsive, responsible bid meeting written specifications.

Award Group #2, Pedestal tables: Recommend acceptance of bid from Virco Inc. as lowest and best responsive, responsible bid meeting written specifications.

Award Group #3, File cabinets: Recommend acceptance of bid from Ernie Morris Enterprises Inc. as lowest and best responsive, responsible bid meeting written specifications.

Award Group #4, Administrative chairs: Recommend acceptance of bid from Ernie Morris Enterprises Inc. as lowest and best responsive, responsible bid meeting written specifications.

Award Group #5, Computer tables: Recommend rejection of low bid from Hertz Furniture, bidding an alternate table with a lower quality wire management system than the model specified. Recommend acceptance of bid from Ernie Morris Enterprises Inc. as lowest and best responsive, responsible bid meeting written specifications.

Notations and Exceptions, continued:

Award Group #7, First aid loungers: No compliant bids received. Requesting permission to purchase on the open market.

Award Group #8, Administrative furniture: Recommend acceptance of bid from Ernie Morris Enterprises Inc. as lowest and best responsive, responsible bid meeting written specifications. Per the bid, the unit price prevails. There was a minor error in the bid extension for PSF13E; Ernie Morris has agreed to honor the adjusted extension price and the all or none Award Group price.

Award Group #9, Teacher furniture: Recommend acceptance of bid from Ernie Morris Enterprises Inc. as lowest and best responsive, responsible bid meeting written specifications. Purchasing has verified the pricing (only bid received in this Group) as fair and reasonable, as it represents a 4% increase over Ernie Morris' bid prices last year (bid 08-001-AZ).

The following Award Groups are still under evaluation, and will be submitted to a future Board meeting: **Award Group #6, Metal shelving; Award group #10, Student music chairs.**

Under Part B, on items where no active or valid bids were received, we will review bids from other counties and school districts, and Florida State Contract, and attempt to "piggyback" where it is in the best interest of the District to do so. We are requesting permission to "piggyback" Pinellas County Schools bid 07-422-003-RN for the following product lines through School Specialty at these discounts off list price: Allied Plastics 38%; Fleetwood 35.1%; Georgia Chair 43.1%; Scholarcraft 43%. We are requesting permission to "piggyback" the same bid for Rubbermaid products through Ernie Morris Inc. at 40.1% off list price. Single orders greater than \$25,000 will be submitted separately for Board approval. We are also requesting permission to negotiate as required with interested parties regarding other manufacturers listed in the bid document. Any such negotiations will be forwarded to subsequent Board meetings for consideration and approval.

The requirements of this bid are for the two (2) new schools and the warehouse as noted above. For all items, quantities listed may vary slightly, but unit prices will remain the same. Offers from other vendors listed herein are the only offers received per the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
