RE: Third Year Renewal of Five-Year Contract

Bid # 07-019-DR: Milk & Milk Products - Food & Nutrition Services

Clover Creek Foods

On July 11, 2006, official action was taken to award the above-referenced bid to Clover Creek Foods. This bid is a five-year contract, renewable annually based upon mutual consent of both parties.

Considering services have been satisfactory, Ivan Whishard, Owner, Clover Creek Foods, was contacted to verify his willingness to enter into the third year of the agreement. As such, Clover Creek Foods has agreed in writing to enter into the third year of the contract with a price increase of \$1.06 per fixed fee. The increase is based on the monthly producer price indexes published by the Bureau of Statistics, U.S. Department of Labor using combined cumulative data with 40% weighting from Industry Data Series ID: #PCU3115113115114, Not Seasonally Adjusted, Industry: Fluid milk manufacturing, Product: Packaged fluid milk and related products using the month of January, final version, and 60% weighting from Industry Data Series ID: #PCU48411-48411, Not Seasonally Adjusted, Industry: General freight trucking, local, Product: General freight trucking, local, using the month of November, final version. The annual percentage change in the Producer price index is based on the November, 2007 index for the third contract year, as stated in the bid documents.

At this time, it is my recommendation to enter into the third year of the agreement with Clover Creek Foods with the requested increase as allowed under the bid's terms and conditions. The third year of the contract will cover the period August 8, 2008 through August 7, 2009. The anticipated annual expenditure will be approximately \$2,000,000.

RE: Second Year Renewal of Three-Year Contract

Bid # 07-019-DR: Milk & Milk Products - Food & Nutrition Services

Clover Creek Foods

On July 11, 2006, official action was taken to award the above-referenced bid to Clover Creek Foods. This bid is a three-year contract, renewable annually based upon mutual consent of both parties.

Considering services have been satisfactory, Ivan Whishard, Owner, Clover Creek Foods, was contacted to verify his willingness to enter into the second year of the agreement. As such, Clover Creek Foods has agreed in writing to enter into the second year of the contract with a price increase of \$1.03 per unit price. The increase is based on the monthly producer price indexes published by the Bureau of Statistics, U.S. Department of Labor using combined cumulative data with 40% weighting from Industry Data Series ID: #PCU3115113115114, Not Seasonally Adjusted, Industry: Fluid milk manufacturing, Product: Packaged fluid milk and related products using the month of January, final version, and 60% weighting from Industry Data Series ID: #PCU48411-48411, Not Seasonally Adjusted, Industry: General freight trucking, local, Product: General freight trucking, local, using the month of January, final version. The annual percentage change in the Producer price index is based on the January, 2006 index for the first contract year, as stated in the bid documents.

Based on the bid document, if a Federal milk marketing order minimum price, increases or decreases the price of raw milk in increments of \$0.10 per hundred weight, thereby increasing or decreasing the cost of said milk \$0.00054 per half pint, the School Board shall adjust the price paid to the milk contractor to conform to the increase or decrease as aforesaid. Any changes in prices must be accompanied by an appropriate copy of the USDA,

Agriculture Marketing Service (SMI), Dairy Programs Announcement of class prices and the Southeast Milk, Inc., price announcement or other pre approved price change announcement. Increase for FMO went from .01973 first year of contract to .02322 second year of the contract. We have recently been informed that the FMO will be increasing again in August, 2007. Currently we do not know the exact amount. When that information is provided to us, we will forward it to the Board for approval.

At this time, it is my recommendation to enter into the second year of the agreement with Clover Creek Foods. The second year of the contract will cover the period August 8, 2007 through August 7, 2008. The anticipated annual expenditure will be approximately \$2,000,000.
