#### **Recommendation:**

## **Term of Contract**:

This is a five (5)-year agreement, renewable annually at the mutual agreement of the parties.

#### **Notations and Exceptions:**

The RFP was issued to identify a firm with which the Board and District Administration can work on an ongoing basis to develop and update its School Board policies, make them available to the public and District personnel via the internet, and keep them continuously compliant with Florida Statutes and best practices. The proposals were evaluated by committee members, with these scores totaled and averaged to determine Phase I scoring. The two (2) firms submitting proposals were invited to interview with the entire committee on June 20, 2007. Scores from the interview were totaled and averaged, and these Phase II scores were added to the Phase I scores for a final total. It is the consensus of the committee that the services of Neola Inc. be retained, and permission is requested to proceed with negotiation of a software license with Neola, incorporating by reference the terms and conditions of the RFP.
