Recommendation:

Term of Contract:

This is a three year contract, renewable annually by mutual agreement of all parties. The first year of the contract will commence on August 21, 2007 and expire on August 20, 2008.

Notations and Exceptions:

This bid was awarded upon a weighted points system. The weighted point criteria were based upon the following weights: Quality (9); Total Price (4); Commission (3); and References (2). Points were assigned on a scale of 5 (High) to 1 (Low) in each of the above entries, then multiplied by the weighted points factor.

Lifetouch National School Studios and Strawbridge Studios were disqualified due to not submitting samples as required in the bid documents.
