<u>Term of Contract</u>: This bid is for digital telephone switching systems (PBX), to be purchased on an as-needed basis by the Information Services Department. PBXs are used in new schools and to retrofit systems in older schools. The bid term is three (3) years, renewable annually at the mutual agreement of the parties.

<u>Notations and Exceptions</u>: The equipment list from the low bidder, Nu-Vision Technologies, d/b/a Black Box Network Services, was reviewed by the Information Services Department. At our request, the company has clarified in writing that they will provide a MAT terminal (PC, monitor, keyboard and mouse) with each PBX per the price as bid.
