<u>Recommendation</u>: Recommend acceptance of AFP Industries and School Specialty as noted on the attached tabulation sheets as lowest and best bids meeting written specifications.

Term of Contract: This is the first year of a three-year contract renewable annually upon mutual agreement of all parties. The first year of the contract will begin on January 2, 2006 and expire on January 1, 2007.

Notations and Exceptions: This bid was designed to be awarded to one vendor per manufacturer listed. Estimated yearly expenditures for this contract are \$150,000.

Bids were awarded on a weighted point system: Discount (10 pts.); Vendor Inventory (5 pts.); and Location (5 pts.). Six "No Bids" were received from ABC School Supply, Childcraft Education Corporation, Nasco, Prentke Romich Company, Science Kit & Boreal Labortories, and Sax Arts & Crafts. Discounts will remain the same throughout the contract term; however, vendors may update catalogs on a semi-annual basis.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
