Recommendation:

Recommend acceptance of bid from Central Food Equipment, Inc., as noted on attached bid tabulation sheet, as lowest and best, responsive and responsible, "all-or-none" bid meeting written specifications.

Term of Contract:

This bid is for Manitowoc Ice Machine Equipment "as needed" by the Maintenance Department for use throughout the District. It is estimated that the balance of line equipment will be \$15,000.00. This is a three-year bid renewable annually based upon mutual agreement of both parties. The first year of this contract shall be effective through March 6, 2008.

Notations and Exceptions:

Beltram Edge Tool Supply, Inc. had an addition error and could not hold their total all-or-none bid price. As per the general terms and condition of the bid, in the event of price discrepancy for an all or none bid the total price will prevail. Therefore they have withdrawn their bid.

Recommend rejection of lower bid from Gulf Ice Systems, Inc. because of failure to meet the written specifications for compatibility with existing systems (nickel impregnated evaporator, automatic cleaning process, hot gas harvest).

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
