RE:	Second Year Renewal of Three-Year Contract Bid # 07-113-GF: USDA Commodity Egg Processing Bid Michael Foods, Inc.

On May 5, 2007, official action was taken to award the above-referenced bid to Michael Foods, Inc. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the contract will expire on June 30, 2008.

Considering services have been satisfactory, Kevin McMenimem, VP-CAA, Michael Foods, Inc. was contacted to verify his willingness to enter into the second year of the agreement, As such, Michael Foods, Inc. has agreed in writing to enter into the second year of the contract with a price increase of \$1.16 per case (except for item #46025-85881-00 Strawberry-Banana Glazed French Toast Sticks, which is not in our bid document). The increase is based on the monthly producer price indexes published by the Bureau of Statistics, U.S. Department of Labor using combined cumulative data with 50% weighting from Industry Data Series ID: #PCU311---311---, Not Seasonally Adjusted, Industry: Food mfg., Product: Food Mfg using the month of November, final version, and 50% weighting from Industry Data Series ID: #PCU48412-48412, Not Seasonally Adjusted, Industry: General freight trucking, long distance, Product: General freight trucking, long-distance, using the month of November, final version. The annual percentage change in the Producer price index is based on the November, 2007 index for the second contract year, as stated in the bid documents.

At this time, it is my recommendation to enter into the second year of the agreement with Michael Foods, Inc. with the requested increase as allowed under the bid's terms and conditions. The second year of the contract will cover the period July 1, 2008 through June 30, 2009.
