**Recommendation:** Recommend acceptance of bids as noted on attached tabulation sheet as lowest and best responsive, responsible bids meeting written specifications.

**Term of Contract:** This bid is for the USDA Commodity Turkey Processing for Food and Nutrition Services for use throughout the District and on behalf of the P.O.W.E.R. Buying Group. (P.O.W.E.R. Buying group is made up of 37 school boards.) This is the first year of a three-year bid, renewable annually by written consent of both parties. The first year of the contract is effective July 1, 2009 through June 30, 2010.

**Notations and Exceptions:** Recommend award to Jennie-O Turkey Store. Jennie-O Turkey Store was the only company to submit bid pricing for all of the products listed, excluding item 20A, Turkey Sloppy Joe product which has been discontinued. As per bid document, Category A will be awarded as "all or none" to the "lowest and best" responsive and responsible total bottom line cost vendor.

Individual School Boards are responsible for their own orders, etc.

Total savings was based on commercial prices (without processing) for the same items. The average prices were then subtracted from the commercial prices.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
