RE: Third Year Renewal of Three-Year Contract
Bid # 07-116-DR: USDA Commodity Sandwich Processing Bid
Café Favorites

On July 24, 2007, official action was taken to award the above-referenced bid to Café Favorites. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The second year of the contract will expire on July 31, 2009.

Considering services have been satisfactory, Len Kretchman, President, Café Favorites was contacted to verify his willingness to enter into the second year of the agreement. Pricing for the next contract year is reflected in the attached chart. All proposed price increases are within the 1.49% Producer Price Index increase allowed under the contract. As such, Café Favorites has agreed in writing to enter into the third year of the contract.

At this time, it is my recommendation to enter into the third year of the agreement with Café Favorites. The third year of the contract will cover the period August 1, 2009 through July 31, 2010. Due to the volume of pages on the original tab sheet, only the items being renewed with the approved increase are attached. Term of Contract: This bid is for USDA Commodity Sandwich Processing for Food and Nutrition Services for use throughout the District. This is the first year of a three-year bid, renewable annually by written consent of both parties. The first year of the contract is effective August 1, 2007 through July 31, 2008.

Notations and Exceptions: Recommend rejection of DFM Diversified Foodservice, Mfg. for not submitting entire bid as stipulated in bid document.

Recommend rejection of J. M. Smuckers for submitting entire bid with no pricing.

Recommend acceptance of sole bid from Café Favorites as the "lowest and best" responsive and responsible bid meeting written specifications.

Although only one responsive, responsible bid received, prices are deemed competitive based upon current commodity prices and current commercial prices. As a comparison, prices between Cafe Favorites and DFM Diversified Foodservice reflect Café Favorites prices are lower price per portion due to case sizes being greater than DFM Diversified Foodservice.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All others submitted in response to the solicitation, if any, are hereby rejected as late.
