#### **MEMORANDUM**

RE: Second Year Renewal of Three-Year Contract Bid # 09-010-DR: Art Supply Catalog Discount Dick Blick Company Nasco Pyramid School Products Sax Arts and Crafts School Specialty

On May 20, 2008, official action was taken to award the above-referenced bid to Dick Blick, Nasco, Pyramid School Products, Sax Arts and Crafts, and School Specialty. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the contract will expire on June 30, 2009.

Considering services have been satisfactory, John Van Fleet, Sales Representative, Dick Blick Company; Dave Johnson, Manager of Sales Contracts, Nasco; John O. Miller, Vice President, Pyramid School Products; Anne Solomko, Consumable Bid Manager, Sax Arts and Crafts; and Jimmie Wilson, Assistant Secretary, School Specialty, were all contacted to verify their willingness to enter into the second year of the agreement. As such, Dick Blick Company, Nasco, Sax Arts and Crafts, and School Specialty all have agreed in writing to enter into the second year of the contract. However, Pyramid School Products was not able to renew the bid due to manufacturing increases on their catalog and they cannot hold the prices.

At this time, it is my recommendation to enter into the second year of the agreement with Dick Blick Company, Nasco, Sax Arts and Crafts, and School Specialty. The second year of the contract will cover the period July 1, 2009 through June 30, 2010.

**<u>Recommendation</u>**: Recommend acceptance of bid as noted on attached bid tabulation sheet as lowest and best responsive, responsible bid meeting written specifications.

<u>Term of Contract</u>: This bid is for the entire District's "as needed" requirements for art supplies and equipment requested by the CIS Department. The percentage bid is firm and fixed for the term of the bid (catalogs may be updated in January and July only). This is a three year bid renewable annually by mutual consent of both parties. The first year of the contract will cover the period of July 1, 2008 through June 30, 2009.

**Notations and Exceptions:** This is a multi-award bid (up to five vendors) based upon a weighted point system which considers, discount, inventory, location and service. The award is determined by ranking the vendors highest to lowest based upon the largest number of points. The following companies are recommended for award: Dick Blick Company (64 points), Nasco (40 points), Pyramid School Products (50 points), Sax Arts and Crafts (75 points), and School Specialty (35 points).

Recommend rejection of bids from Discount School Supply, Ellison Educational Equipment, Kaplan Early Learning Company, Lakeshore Learning Company, Quill Corporation, S & S Worldwide, and U. S. Toys Company for failure to meet one or more of the following specifications: 1) catalog inventory of Art related items were not sufficient to analyze bid, 2) does not meet F.O.B. requirements.

Total savings was based on past usage.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All others submitted in response to the solicitation, if any, are here by rejected as late.
