The vendors awarded this bid are: Global Food's Inc., McLain Food, Inc., and Tools for Schools, and Super Bakery, Inc. Two of the four vendors have agreed to extend the terms and conditions of this bid.

Matthew Warnick, Sales Representative, Global Food's Inc. and Kelly Kraus Lejeune, Sales Representative, Tools for Schools, have agreed to extend the terms and conditions of this bid. However, Karen Cahill, Corporate Administrator, Super Bakery, Inc. did not agree to extend the terms and condition of this bid. After several attempts, by fax and phone calls, McLain Foods, Inc. did not respond. Therefore, the District will not be renewing with McLain Foods, Inc.

At this time, it is my recommendation to enter into the fifth year of the agreement with Global Food's, Inc. and Tools for Schools. The fifth year of the contract will cover the period June 22, 2009 through June 21, 2010.

Recommendations:

Recommend acceptance of bid as noted on attached bid tabulation as lowest and best bid meeting written specifications.

Terms of Contract:

This bid is to allow the Food & Nutrition Services Department the ability to purchase “Opportunity Buys” and “Special Buys” offered throughout the year from various food manufacturer’s at a discounted price. This is a three-year bid renewable annually by mutual consent of both parties. The first year of the contract is effective June 22, 2005 through June 21, 2006.

Notations and Exceptions:

There is no dollar amount listed on the attached tab sheet because manufacturer’s throughout the year may have special buys, (i.e. a 20-30% discounted price for various food items in the categories listed on the tab sheet that were an overrun at the manufacturing plant, or ordered by a specific company and then the order was cancelled before being shipped). There is no way to determine the number of special buys, nor the kind of items that will be available during a given year. This bid is in place to allow the Food & Nutrition Services Department the ability to take advantage of these offers at considerable savings to the School District.

As these offers are received from the vendors, the Food & Nutrition Services Department will do a cost comparison to verify that it is beneficial to the district.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
