# **Recommendation:**

Recommend acceptance of RFP per the attached RFP tabulation. As per the terms of the RFP, the District has reserved the right to use the services of the second-ranked or third-ranked firm if the volume of work or response time required exceeds the highest-ranked firm's ability to successfully perform.

# **Term of Contract:**

This is a contract for a Roofing Consultant for the Maintenance Department to be used throughout the District. This is a three-year agreement renewable annually based upon mutual agreement of both parties. The first year of this contract shall be effective from June 21, 2008 to June 20, 2009. Unit Prices are firm, however, the total amount will vary depending on the numbers of projects and type of work.

# **Notations and Exceptions:**

The evaluation consisted of a selection review committee, made up of representatives from the Maintenance and Facility Operations Department. Each RFP was evaluated according to a weighted point system (i.e. Firm's Profile 10, Firm's Technical Qualifications 25, Pricing 25) as outlined in the specifications with scores totaled and then averaged to obtain a ranking, highest to lowest. Recommend acceptance of Rogers & Sark Consulting, Inc. as the first-ranked firm, George Butler Associates, Inc. as the second-ranked firm, and A/R/C/Associates, Incorporated as the third-ranked firm. Copies of the evaluation forms are on file in the Purchasing Department.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
