Additional Sandwich Products

On July 24, 2007, official action was taken to award the above-referenced bid to Café Favorites on an all or nothing basis on July 24, 2007 and renewed on May 6, 2008.

Under the terms and conditions of the bid, as new products become available they may be added to the bid. Steve Atchinson, Vice President of National Sales, Café Favorites, has submitted pricing for twelve (12) new products. The twelve products are:

- Item #63863: Italian Sub, at case price of \$97.65, 63/7.3 ounce servings per case
- Item #63360: Peppered Ciabatta, at case price of \$105, 60/7.2 ounce servings per case
- Item #63260: Panini-Oven Roasted Turkey Breast & Cheddar on Ciabatta Panini, at case price of \$93, 60/8.4 ounce servings per case
- Item #63460: Panini-Virginia Ham & Provolone on a Ciabatta Panini at case price of \$93, 60/7.9 ounce servings per case
- Item #01696: Flava Fusion – Whole Grain Spicy Grilled Cheese, at case price of \$60.83, 96/4.6 ounce servings per case
- Item #02696: Flava Fusion – Whole Grain Spicy Gilled Cheese – Individually Wrapped at case price of \$61.79, 96/4.6 ounce pound servings per case
- Item #03696: Panini Fusion Whole Grain Gilled Cheese and Tomato at case price of \$60.83, 96/4.6 ounce servings per case
- Item # 04696: Flava Fusion Whole Grain Gilled Cheese and Tomato – Individually Wrapped, at case price of \$61.79, 96/4.6 ounce servings per case
- Item #05696: Flava Fusion – Whole Grain Gilled Cheese and Pizza in Mozzarella at case price of \$67.79, 96/4.6 ounce servings per case
- Item #05666: Flava Fusion – Whole Grain Gilled Cheese and Pizza in Mozzarella – Individually Wrapped at case price of \$68.75, 96/4.6 ounce servings per case
- Item #13196: Whole Grain Toasty Dog – All Turkey Hot Dog, at case price of \$42.81, 96/3.1 ounce servings per case

- (12) Item #14196: Whole Grain Toasty Dog – All Turkey Hot Dog – Individually Wrapped, at case price of \$43.77, 96/3.1 ounce servings per case. (Pricing information attached.) Pricing on these products is below retail prices and found to be competitive.

Adding these twelve items will allow us a greater opportunity to utilize the USDA Commodity Sandwich Processing sent to Café Favorites.

Rick Kurtz, Director, Food and Nutritional Services is recommending to add these products to our USDA Commodity Sandwich bid. The estimated annual purchases are anticipated to change the total bid award from \$200,000 to \$300,000 using Special Revenue Funds.
