On February 20, 2009, official action (attached) was taken to award the above-referenced bid to East Side Entrees, JTM Provisions Company, Inc., Land O'Lakes, Inc., Schwan's Food Service, Inc., Rich Products Corporation, and Tasty Brands. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement will expire on June 30, 2010.

Considering services have been satisfactory, Jeff Rowe, Vice President of Operations, East Side Entrees, Brian Hofmeier, Director of School Sales, JTM Provisions Company, Inc., Jerry Kaminski, Vice President/General Manager, Land O'Lakes, Inc., Pat McCoy, Vice President of Field Sales, Schwan's Food Service, Inc., Diana Martinez, Commodity Coordinator, Rich Products Corporation, and David Horowitz, E. V. P. Sales & Marketing, Tasty Brands, was contacted to verify their willingness to enter into the second year of the agreement. As such, they have agreed in writing (attached), to enter into the second year of the contract.

USDA timeline for school districts to place orders for commodity foods and identify processing manufacturers is January 15, 2010 for the 2010/2011 school year. Due to the USDA timeline, it is necessary to renew commodity processing bids six (6) months prior to the term of the contract. Purchase orders and product orders through distributors will not be placed with awarded vendors prior to July 1, 2010. This bid in no way affect contracts already in place for the 2009-2010 school year. Because of the USDA timeline, Food and Nutrition Services is requesting permission from The Board to renew Bid #10-25-DR: USDA Commodity Peanut Butter Processing bid six months prior to term of contract.

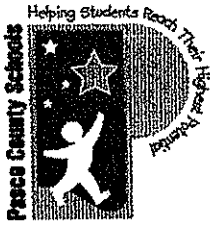
