## MEMORANDUM

Quality Plywood Specialties, Inc. (Renewal)

On February 17, 2009, official action (attached) was taken to award the above-referenced bid to the vendors noted. This bid was awarded by groups and is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement will expire on February 3, 2010.

Considering services have been satisfactory, Michael Jankowski, President, Quality Plywood Specialties, Inc. was contacted to verify his willingness to enter into the second year of the agreement. As such, Michael Jankowski has agreed in writing (attached), to enter into the second year of the contract.

The terms and conditions of the bid allow for price adjustments at the annual renewal based upon the change in the Producer Price Index (PPI) published by the Bureau of Statistics, U.S. Department of Labor, using Series ID: #WPU081, Not Seasonally Adjusted, Group: Lumber and wood products, Item: Lumber. A decreased price adjustment of 0.894 was requested by the Purchasing Agent and is in accordance with the PPI published allowance. Quality Plywood Specialties, Inc. has agreed to the adjustment (see attached).

Further, HD Supply White Cap and Perillo & Associates, LLC chose not to renew their awarded portion of the contract. This lumber will be purchased after receiving written quotes.

At this time, it is my recommendation to enter into the second year of the agreement with Quality Plywood Specialties, Inc. The second year of the contract will cover the period of February 4, 2010 through February 3, 2011.
