Lyle Bleachers, Inc.

On April 21, 2009, official action (attached) was taken to "piggy-back" the School Board of Broward County Bid #27-107T. This recommendation was for \$75,000 for the period of April 1, 2009 through March 31, 2010.

The Maintenance Department has determined that an additional \$16,000 will be needed for this period of time. This increase is due to safety issues and repairs to bleachers for code compliance.

At this time, we are requesting permission to place additional purchase orders not to exceed \$16,000 for the period of March 3, 2010 through March 31, 2010 in order to reduce delays in processing purchase orders. The funding is provided through the general fund and capital fund. As always, the Purchasing Department will monitor and calculate all Lyle Bleachers, Inc. purchase orders to verify that the dollar limits are not exceeded.
