Recommend rejection of low bid from School Specialty, as product did not meet weight bearing loads for shelves on items PSF11G and PSF11F. *Recommend acceptance of bid from Hertz Furniture as lowest and best responsive, responsible bid meeting written specifications, at an all-ornone price of \$64,981.97. (Unit prices prevailed in extension error.)

Award Group #9, Teacher Furniture

Recommend rejection of low bid from School Specialty as product did not meet specifications (i.e. the desk does not have radius edges, does not have bookshelf for storage or a center pencil drawer.) *Recommend acceptance of bid from Ernie Morris Enterprises as lowest and best responsive, responsible bid meeting written specifications, at an all-or-none price of \$107,145.50.

Cost savings for the above-referenced awards are calculated based upon the difference between the highest bid and recommended bid received for each Award Group - approximately **\$76,493.13**.
