Lease of Ricoh Pro C900S 2<sup>nd</sup> year of 5-year lease Ikon Office Solutions

On April 21, 2009 the Board approved the Graphic Services Department's request to "piggyback" US Communities contract 58795-City of Los Angeles for the lease of the Ricoh C900S copier with Ikon Office Solutions. The first year of the lease is set to expire on April 20, 2010.

Considering services have been satisfactory, Ikon Office Solutions was contacted to determine their willingness to enter into the second year. They have indicated in writing that they are willing to do so. Services covered under this contract are exempt from the competitive pricing requirements as outlined in under DOE's Rule 6A-1.012(5), the Board may make purchases to vendors awarded by other governmental agencies.

The equipment lease amount and estimated usage are as follows: April 21, 2010 through April 20, 2011 lease amount is \$27,714.72 April 21, 2010 through April 20, 2011 estimated usage charges \$15,000 Total for April 21, 2010 through April 20, 2011 is \$42,714.72.

Therefore, it is my recommendation that this piggyback renewal be approved with the company referenced above. The piggyback will cover the period of April 21, 2010 through April 20, 2011.
