Recommendation:

Recommend acceptance of the bid from DeMoulin Brothers & Company as noted on the attached tabulation sheet as the lowest and best bid meeting written specifications and testing criteria.

Term of Contract:

This is a one-time purchase. Prices to remain firm for 90 days after receipt of uniforms.

Notations and Exceptions:

This bid is for marching band uniforms to be utilized by Anclote High School and is part of the start-up band program at Anclote High School. Band uniforms are part of a rotational uniform program for the District and are replaced approximately every seven years.

Recommend rejection of lower priced bid from Fruhauf. The bartacks, quilt stitching, and polymer slides specified were not used in the sample uniform and could not be evaluated for quality of construction. The required color swatch samples were not provided for evaluation of color and fabric mill-weight. The specifications required the headgear emblem to be attached by prongs and a glued emblem is unacceptable; the emblem on the headgear sample submitted by Fruhauf was glued. Shoulder pads were constructed of foam which is unacceptable per the bid specifications. Shako box is not stackable and does not have replaceable snap closures as stated in the bid specifications.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
