Term of Contract:

This is an annual purchase for office products to be stocked in the central warehouse for use throughout the District.

Notations and Exceptions: Recommend acceptance of all low bids as meeting the written specifications and testing criteria as specified in the bid documents with the following exceptions:

OS-07: Tie between Standard Stationary Supply and Pyramid School Supply is recommended to Pyramid School Supply by toss-of-the-coin, as outlined in the specifications. Toss-of-the-coin was witnessed by two District employees (on file in the Purchasing Department).

OS-23 through 27: Recommend acceptance of “all or none” bid from Pyramid School Supply as lowest and best, responsive, responsible bid meeting written specifications and testing criteria. Although there was an error in Pyramid’s “total” for this group, unit prices were correct and reflect the correct total. Lower bid from Standard Stationary Supply is disqualified as outlined in the bid specifications for bidding multiple items for one item number.
