**Recommendation:**

Recommend acceptance of bids as noted on the attached tabulation sheet as lowest and best bids meeting written specifications.

**Term of Contract:**

This is an annual purchase for classroom supplies to be stocked in the central warehouse for use throughout the District.

**Notations and Exceptions:**

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

**Item CS005:** Recommend acceptance of bid from Bye-Mo'r, Inc., as lowest and best, responsive and responsible bid meeting written and testing specifications. Recommend rejection of lower bids from Ace Office Supplies and DGS Educational Products as their items did not erase well. Recommend rejection of Business Stationers as their item was too small and did not meet specification as outlined in the bid document. Recommend rejection of AFP Industries, Inc. and Pyramid School Products for failure to submit samples as required. Standard Stationary Supply was disqualified for bidding more than one alternate item (two items) as outlined in the bid document.

**Item CS009:** Recommend acceptance of bid from Bye-Mo'r, Inc., as lowest and best, responsive and responsible bid meeting written and testing specifications. S & S Worldwide has requested their bid be withdrawn due to an error in pricing. Recommend rejection of Business Stationers as their product was difficult to use (open and squeeze). Recommend rejection of lower bid from APF Industries, Inc. for failure to submit sample as required.

**Notations and Exceptions:**

**Item CS0009A:** Recommend acceptance of bid from Standard Stationary Supply, as lowest and best, responsive and responsible bid meeting written and testing specifications. Recommend rejection of lower bids from AFP Industries, Inc. and Business Stationers for failure to submit samples for evaluation.

**Item CS012:** Recommend acceptance of bid from Pyramid School Products, as lowest and best, responsive and responsible bid meeting written specifications. Tie breaker for Standard Stationary Supply was determined by Drug Free Work Place. Recommend rejection of lower bid from Quill.com as their item did not meet specifications as outlined in the bid document.

**Item CS014:** Recommend acceptance of bid from S & S Worldwide, as lowest and best, responsive and responsible bid meeting written and testing specifications. AFP Industries, Inc. was disqualified because they tied their unit prices to minimum quantities. Recommend rejection of lower bids from Pyramid School Products and Business Stationary as their overhead pens wrote too thin with poor coverage.

**CS021:** Recommend acceptance of bid from Standard Stationary Supply, as lowest and best, responsive and responsible bid meeting written and testing specifications. Recommend rejection of lower bids from Business Stationers and Pyramid School Products as the plastic was of poor quality and broke easily.

**CS022B:** Recommend acceptance of bid from Pyramid School Products, as lowest and best, responsive and responsible bid meeting written specifications. Recommend rejection of lower bid from Standard Stationary Supply as their product was of poor quality (weak plastic).


