On May 6, 2008, official action (attached) was taken to award the above-referenced bid to Suncoast Paving, Inc. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the agreement expired on May 17, 2009. Subsequently, the second year of the agreement was awarded on April 21, 2009 and covers the period of May 18, 2009 through May 17, 2010.

Considering services have been satisfactory, Joe Martin, Senior Estimator, Suncoast Paving Inc. was contacted to verify his willingness to enter into the third year of the agreement. As such, Joe Martin has agreed in writing (attached), to enter into the third year of the contract.

The terms and conditions of the bid allow for price adjustments at the annual renewal based upon the change in the Producer Price Index (PPI) published by the Bureau of Statistics, U.S. Department of Labor, using Series ID: #WPU13940113, Not Seasonally Adjusted, Group: Nonmetallic mineral products, Item: Asphalt paving mixtures and blocks. A price adjustment of 1.195 has been requested and is in accordance with the PPI published allowance.

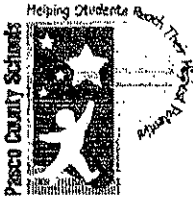

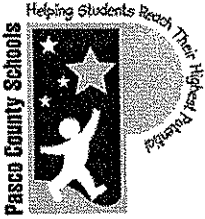
