Cobb Pediatric Therapy Services, Community Rehab Associates, Educational

Based Services, and Special Communications

On June 16, 2009, official action (attached) was taken to approve award of the above-referenced RFP to ABC Speech & Language Therapy, Beth Ingram Therapy Services, and Independent Living. The RFP establishes providers for licensed speech and language services for use throughout the District. The RFP is a three (3)-year contract, renewable annually at the mutual agreement of the parties. The first year term is July 1, 2009 - June 30, 2010.

Since the inception of the RFP, the three (3) awarded firms have been unable to provide the number of therapists required to meet the District's needs (see attached memo from Ms. Monica Verra, Director of Exceptional Student Education). Ms. Verra has requested that the four (4) next highestranked providers from RFP 09-111-AF be added to the list of approved providers for the District.

All four (4) firms have been contacted to ascertain if they would be willing to extend the terms, conditions and pricing of the original RFP to the District. All firms have confirmed in writing (attached) that they are willing to do so. The term for their contract will begin at Board approval and extend through June 30, 2011. The renewal of the second contract term with the suppliers originally awarded work under the RFP will be sent to a future Board meeting for approval. Funding for this program is provided through general funds, and/or the IDEA Part B Grant.

At this time, it is my recommendation that the suppliers noted above be added to the list of approved suppliers for licensed speech pathology services, for use by the District as needed. Please contact Ms. Verra or me if you have any questions or concerns regarding this matter.

Recommendation:

Recommend acceptance of RFP's as noted on the attached bid tabulation sheet, as having the highest average scores and best RFP's meeting written specifications.

Term of Contract:

The intent of this proposal is to establish providers for licensed speech and language services for use throughout the District. This is a three-year contract renewable annually based upon mutual agreement of the parties. The first year of this contract is effective from July 1, 2009 through June 30, 2010. Pricing will remain firm and in effect throughout the term of the contract.

Notations and Exceptions:

This is a multi-award bid (minimum of three vendors) based upon the highest average scores. Each RFP was evaluated according to the criteria outlined in the specifications, with individual scores totaled and averaged to obtain the respondents with the highest average scores. Copies of the evaluation forms are on file in the Purchasing Department.

Career Staff Unlimited and Speech & Language Professional Services were disqualified at the proposal opening for failure to provide a confidentiality agreement and company profile as outlined in the Mandatory Submittals section of the RFP documents. Recommend rejection of proposals from following firms:

• Cambridge Healthcare as a request for clarification confirmed that pricing was based on a 7.5 hour work day, which is contrary to the specifications of the RFP.

- Cumberland Therapy Services, LLC for providing a counterproposal stating that their
 hourly rates do not include mileage and that if a therapist is required to work at more than
 one school in the same workday there will be a charge for mileage.
- Staffing Options and Solutions, Inc. (SOS) for submitting pricing that was based on a 7.5 hour work day, which is contrary to the specifications of the RFP.
