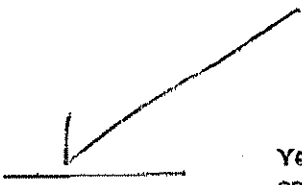

Recommendation: Recommend acceptance of bids as noted on the attached tabulation sheet.

Term of Contract:

This bid is for District charter bus service on an "as needed" to be used throughout the District. This is a three-year contract, renewable annually by mutual agreement of all parties. The first year of the contract will commence on July 1, 2009 through June 30, 2010.

Notations and Exceptions:

This is a multiple award bid to a maximum of eight vendors based upon written specifications. We are awarding to the four vendors as noted as lowest and best, responsive, responsible bids. Multiple awards are required on this bid due to the volume of field trips (342 for 2008). Schools will be free to choose the vendors of their choice based upon availability. Total dollars were calculated based on past historical usage. Total savings were based on average price minus estimated dollar value.

Award of bid to American Coach is contingent upon driver's meeting Jessica Lunsford Act clearance per bid specifications.

Martz – First Class Coach award is based on using only 47 and 55 passenger buses. Other buses, i.e. 35 passenger bus and 10 passenger van are unacceptable for student transportation and will not be used.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
