Considering services have been satisfactory, Community Hospital was contacted to determine their willingness to enter into the second year of the agreement. They have agreed in writing (attached) to do so.

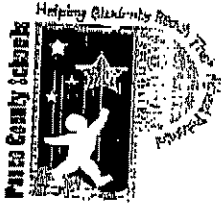


