Term of Contract: This bid is for the Bread and Bread Products for Food and Nutrition Services for use throughout the District. This is the first year of a three-year bid, renewable annually by written consent of both parties The first year of the contract will cover the period of August 8, 2008 through August 7, 2009.

Notations and Exceptions: Recommend acceptance of bid from Butterkrust Bakery as the "lowest and best" responsive and responsible bid meeting written specifications. Award was based on total "All or None" pricing as specified in the bid. Grand total is an estimate only. Prices must remain firm and fixed for the first four (4) months of the contract (July through October). The School District may grant fee increases (or decreases) at four (4) month intervals. Prices must remain firm for each four (4) month interval thereafter (November through February, and March through June).
