RE: Piggyback Request for James W Mitchell High School

RFP # 08-134-Land O' Lakes High School Pictures—Bryn-Alan/Lifetouch

On May 5, 2009, official action was taken to allow James W Mitchell High School to piggyback RFP 08-134-SN Land O' Lakes High School Pictures. This request expires on June 21, 2010. James W Mitchell High School is requesting permission to piggyback Land O' Lakes High School Pictures RFP # 08-134-SN awarded to Bryn-Alan/Lifetouch to cover school pictures for next school year beginning on June 22, 2010.

The third year renewal for the Land O' Lakes High School Picture RFP # 08-134-SN with Bryn-Alan/Lifetouch is included in a separate memo and being presented to this board meeting. Bryn-Alan/Lifetouch was contacted to verify their willingness to extend this contract to James W Mitchell High School. They have indicated in writing (attached) that they are willing to do so. The contract will cover the period of June 22, 2010 through June 21, 2011.

During the past year, Bryn-Alan Photography merged with Lifetouch and performance issues occurred. As a result, some schools have chosen not to renew their contracts and have selected other alternatives, including rebidding. The schools listed below have chosen to finish out their contracts and Nancy Alfonso, School Board Attorney, concurs that these schools can legally do so as their contracts are not contingent upon the satisfactory performance of the other bids that were not renewed.
