Kaplan Early Learning, TherAdapt Products, Inc., and Rifton Equipment

On July 10, 2007, official action (attached) was taken to award bid 07-121-MK to the above-referenced vendors. This is a three-year bid renewable annually at the mutual agreement of the parties. The third year of the agreement will expire on July 9, 2010.

Considering the services have been satisfactory, the vendors were contacted to determine their willingness to enter into a one-year extension of this contract under the existing terms and conditions.
