This letter is in reference to the District School Board of Pasco County's Bid # 08-129-SN for Land O' Lakes High School Yearbooks. As per the certified letter mailed to you on March 18, 2009, Walsworth was asked to address issues that were occurring at Land O' Lakes High School.

The following problems from the previous letter continue to occur:

- Image Placer, the accounting program and indexing plug-in must be operating correctly immediately **(The Image Placer and index program are still not working properly)**
- Individual logins need to be immediately put in place without permission issues, an administration login that can override any permission issue if they should arise, as well as lab and server set up. **(A Walsworth Tech Specialist worked for hours on Image Placer and Individual Logins. Neither work properly as of June 1, 2009.)**

In addition, the following issues have occurred recently:

- **Yearbooks (663 books) were delivered to the school with varying degrees of warping and wavy pages.**
- **After a few weeks of use, some of the books have been breaking down at the spine and mushrooming at the binding.**

Considering the above information, please be advised that the District will not be renewing your contract for Land O' Lakes High School effective July 25, 2009. Should you have any questions or concerns, please feel free to contact me at your earliest convenience.

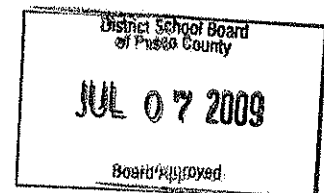

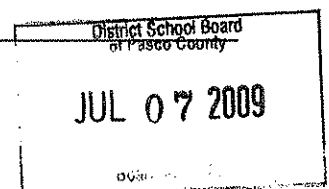
