**Recommendation:**

Recommend acceptance of bid from Cheyenne Asphalt, Inc., as noted on the attached bid tabulation sheet, as lowest and best, responsive and responsible "all-or-none" bid meeting written specifications.

**Term of Contract:**

This bid is for asphalt patching and speed bumps on an "as needed" basis to be used by the Maintenance Department at various locations throughout the District. This is a three-year contract, renewable annually, based upon mutual agreement of both parties. The first year of this contract shall be effective from July 26, 2009 to July 25, 2010. The bid prices are firm and fixed for the first year of the contract and may be adjusted annually based on changes in the Producer Price Index of #WPU139401-.

**Notations and Exceptions:**

Lowest and best, responsive and responsible, bidder was determined by totaling three typical jobs and then adding all three jobs together to determine the lowest (attached).

Savings were determined by averaging the totals for three typical jobs as outlined in the bid specifications and subtracting the recommended vendor's price.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

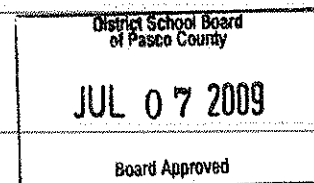

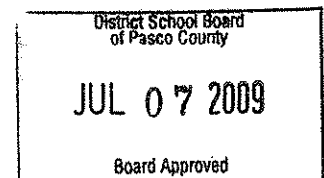
