Permission to Submit a Communication Services Authorization to

Hayes E-Government Resources for Child Internet Protection Act Filter Licenses

E-rate Contract DMS-08/09-061

Per Florida law, the District is required to have Child Internet Protection Act (CIPA) filtering on its servers. As noted in the attached memo from Mr. Bruce Baldwin, Director of Information Services, these CIPA filtering licenses, which are currently installed on District servers, had previously been provided for free by the Department of Education (DOE).

DOE is no longer providing these licenses, known as Websense, free of charge. The Florida Department of Management Services (DMS) has negotiated the above-referenced E-rate contract with AT&T, valid through June 30, 2012. The contract (on file in the Purchasing Department) permits governmental entities to contract with AT&T's authorized sub-contractor, Hayes E-Government Resources, for Websense licensing at a price of \$2.60 per license. The District requires 30,000 licenses to be CIPA compliant. The cost for this mandated service will therefore be \$78,000 for the period July 1, 2010 – June 30, 2011, to be paid out of capital funds.

The District is permitted to purchase goods and services from State contracts under Florida Administrative Rule 6A-1.012(5). We are also authorized by Florida Administrative Rule 6A-1.012(14) to negotiate for high-technology purchases of this nature. If Board permission is granted, the Information Services Department will submit a Communication Services Authorization (CSA) for Websense to DMS, using the attached quote from Hayes E-Government Resources as its basis.


Renewal for Websense Content Filtering
