SUBJECT: PreKindergarten Services and Pasco Learning and Activity Centers for Enrichment (PLACE) Agreement for 2010-2011 School Year

The attached interagency agreement between the District School Board of Pasco County's PreKindergarten Services and the PLACE Program is for seventy (70) Head Start children (4 year olds) to attend the PLACE Program for 2010-2011 school year at Anclote Elementary School, Fox Hollow Elementary School, Pasco Elementary School, Mittye P. Locke Elementary School, Chester W. Taylor Elementary School and Northwest Elementary School.

The specific services are outlined in the agreement and are attached for your perusal. Prekindergarten Services shall pay a flat fee of \$150,000 for services during the 2010-2011 school year for the schools listed above. Head Start Federal funding will be used to provide these services. The services covered under this contract are considered educational services and therefore are exempt from the competitive pricing requirements as outlined in Department of Education 6A-1.012(11)(a). This agreement has been reviewed and approved by Nancy Alfonso, School Board Attorney.

SUBJECT: **Approval of the 2010-11 Agreement for School Year Extended Day Services between Pasco Learning and Activity Centers for Enrichment (PLACE) and Prekindergarten Services**

Introduction

The Head Start refunding application for 2010-11 includes the dual enrollment of four year olds in the Voluntary Pre-Kindergarten program. Funds generated through dual enrollment facilitate the provision of extended day services for enrolled Head Start children through Pasco Learning and Activity Centers for Enrichment (PLACE). The need for this service is supported by Community Assessment results and data collected through the Head Start application process. There continues to be a need for extended quality care among working Head Start families.

Description

Pasco Learning and Activity Centers for Enrichment (PLACE) has agreed to provide extended care services for seventy (70) Head Start children during the 2010-11 school year at the following schools: Anclote Elementary, Fox Hollow Elementary, Pasco Elementary, Mittye P. Locke Elementary, Chester W. Taylor Elementary and Northwest Elementary. The Agreement ensures collaboration between programs for the implementation of extended care services that are in compliance with Head Start regulations and high quality services.

Action Requested

Approval of the 2010-11 Agreement between Pasco Learning and Activity Centers for Enrichment (PLACE) and Prekindergarten Services is needed in order to provide extended care for Head Start enrolled Children.

Recommendation

The staff respectfully requests the approval of the 2010-11 Agreement for School Year Extended Day Services between Pasco Learning and Activity Centers for Enrichment (PLACE) and Prekindergarten Services.

THIS AGREEMENT is made and entered, by and between Pasco Learning and Activity Centers of Enrichment (PLACE) and the Department of Prekindergarten Services, which includes the Head Start preschool program.

WHEREAS, Pasco Learning and Activity Centers of Enrichment (PLACE) provides extended day services through school year of 2010-11.

WHEREAS, Prekindergarten Services has been awarded grant funding for the purpose of providing Head Start services to children enrolled through the Pasco County school system.

NOW, THEREFORE, the parties agree to collaborate on the following:

- Recruitment of families and assistance with the application process
- Selection and enhancement of the curriculum
- Ensuring that all children's needs are met
- Monitoring each site for compliance in accommodating any special needs or individual nutrition needs, including children with disabilities
- Seeking and delivering training opportunities that will support high quality services
- Acting as a resource for each other as needed, or as requested
- Managing and communicating behavior and discipline concerns
- Promoting family involvement and conducting follow-up as needed
- Program planning and evaluation
- Ensuring that children must comply with PLACE enrollment criteria as stated in the PLACE Parent Handbook in order to ensure the safety and well-being of all children served by the program

Prekindergarten Services and Pasco Learning and Activity Centers of Enrichment (PLACE) agree to abide by the District School Board of Pasco County's Code of Student Conduct.

Head Start children served under this Agreement are eligible to receive extended day services 6:30 A.M. to 6:00 P.M. according to the published PLACE calendar.

Head Start children served under this Agreement will not be charged for services. The exception will be a charge to individual families for late-pick-up that extends beyond 6:00 P.M.

Head Start children served under this Agreement will receive a snack in the morning and in the afternoon, in accordance with district nutritional policies.

Prekindergarten Services shall pay a flat fee of \$150,000 for extended day services for 70 children enrolled in the 2010-11 Head Start preschool classes.

Anclote Elementary School
Fox Hollow Elementary School
Pasco Elementary School (San Antonio Elementary, Rodney B. Cox Elementary, Lacoochee Elementary, Centennial Elementary)
M.P. Locke Elementary School
Chester W. Taylor Elementary School (West Zephyrhills Elementary)
Northwest Elementary School




