#### **Recommendation**:

Recommend acceptance of bid from Florida Technical Operations as the primary award and BLM Technologies, Inc., as the secondary award contingent upon completion of successful references, as noted on the attached bid tabulation sheet, as lowest and best, responsive and responsible bids meeting written specifications.

#### **Term of Contract:**

The intent of this bid is to establish pricing for Dell computer support services and repair of Dell computers on an "as needed" basis to be used throughout the District. This is a three-year bid renewable annually based upon mutual agreement of the parties. The first year of this contract shall be effective from September 17, 2008 through September 16, 2009.

#### **Notations and Exceptions:**

Award of this bid was based on the average of straight time hourly rate for desktop and laptop computers. Work will be awarded to Florida Technical Operations as needed; if they are unable to meet the District's required timelines we are asking for permission to contact BLM Technologies, Inc. as outlined in the bid specifications.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.

Savings were determined as the difference between the average straight time hourly rates for desktop and laptop computers for the highest-bidding vendor and the lowest-bidding vendor for a one-year period.
