
On September 2, 2008, official action (attached) was taken to award the Temporary Personnel Services bid to the above-referenced vendors. This bid is a five-year contract, renewable annually based upon mutual consent of the parties. The third year of the agreement will expire on September 4, 2009.

Considering services have been satisfactory, all companies were contacted to determine their willingness to enter into the fourth year of the agreement. They have agreed in writing (attached) to do so. Due to an increase in Florida's Minimum Wage, effective January 1, 2009 (attached), the above listed companies are entitled to an increase of \$.04/hour as the minimum wage has changed from \$7.21 to \$7.25. This increase is allowed per the terms of the original bid.

It is my recommendation at this time to enter into the fourth year of the agreement with the vendors noted above with the adjustment of \$.04 added to each hourly rate. The fourth year of the contract will cover the period of September 5, 2009 through September 4, 2010. SUBJECT:

Florida's Minimum Wage Increase Scheduled for January 2009

Effective January 1, 2009, Florida's minimum wage will increase to \$7.21 per hour for all hours worked in Florida. The direct wage for employees who receive tips will increase to \$4.19 an hour as of January 1, 2009. Florida's minimum wage was created in a constitutional amendment approved by voters and covers all employees in the State covered by the federal minimum wage. Please also note that the federal minimum wage will increase to \$7.25 on July 24, 2009. On this date, Florida employers must increase the minimum wage from \$7.21 to \$7.25. A reminder will be sent prior to the federal change.

The change in the minimum wage affects workforce programs such as the Welfare Transition and Food Stamp Employment and Training Programs where the calculation of the number of hours customers are required to engage in work activities is based on the higher of the state or federal minimum wage. It also affects programs such as the Workforce Investment Act and the Wagner-Peyser Act Programs that need to ensure that job orders and job placements are in compliance with the minimum wage laws. Additional Information regarding the impact of these changes for various workforce programs is described in the attachment provided with this memorandum.

Please share this information with staff and administrators that work with the Food Stamp Employment and Training (FSET), Wagner-Peyser (WP), Welfare Transition (WT), and Workforce Investment Act (WIA) programs.

Tri-State Employment

On September 5, 2006, Tri-State Employment was one of six vendors awarded portions of the above-mentioned bid. Tri-State Employment was awarded Job Category I for Food Service Worker, Custodial Worker, and Clerical Worker.

The Custodial Services Department and the Purchasing Department have made several attempts to work with Tri-State Employment in regards to custodial temporary services workers. Custodial Services has requested help for custodial services on several occasions, by fax and phone. No one from Tri-State Employment has returned their calls or sent workers to meet the needs of the District.

The Purchasing Department has spoken with Susan Kennedy, Contract Manager, regarding Temporary Custodial Services both by phone and by e-mail and was told that Tri-State Employment would be honoring the bid and would be sending temporary help when requested. To date, no workers have been provided.

On December 19, 2006, Purchasing sent a certified letter to Tri-State Employment asking them to provide written documentation on how they anticipate complying with the bid. Purchasing received an e-mail from Susan Kennedy, Contract Manager, on January 11, 2007, stating that they are still working on the situation and have been trying to recruit workers but to no avail.

The district has not been able to hire the temporary custodial service help needed from As there appears to be no improvement in Tri-State's ability to meet our bid requirements, we are requesting to have Tri-State's award rescinded and reawarded to Express Personnel Services, the next lowest vendor. Further, we recommend to the School Board that Tri-State Employment be removed as a future bidder for a period of three years due to failure to perform.
