## **MEMORANDUM**

RE: Requesting Approval of Additional Expenditures  
Bid #10-023-DR: Garbage Services  
Central Carting

On May 19, 2009, official action was taken to award Part B, Roll-Off Services for solid waste for the above-referenced bid to Central Carting. This bid is a three-year contract, renewable annually based upon mutual consent of both parties. The first year of the contract began on July 1, 2009 and continues through June 30, 2010.

At the time of award, we awarded Part B to Central Carting in the amount of \$1,438 which is the total price for each type of roll-off. The amount of roll-offs that the District uses each year varies depending on what items need to be disposed of, renovations, etc. Half of the expenditures will be for 20 yard Roll-Off Container Garbage/Recycle and the other half of the amount requested will be for 20 yard Roll-Off Container Construction Debris. Resource and Recovery Services is requesting an increase of the awarded amount of \$43,561.60, for a total of \$45,000 for the 2009/2010 school year. Funding Source: Solid Waste Conservation/Other Internal Service.

**Term of Contract:** This is the first year of a three-year bid, renewable annually by written consent of both parties. The first year of the contract will cover the period of July 1, 2009 through June 30, 2010.

**Notations and Exceptions:**

PART A: Recommend acceptance of bid from Waste Services of Florida, Inc. As per the bid documents. Part A will be awarded as an “all or none” group with the “lowest and best” responsive and responsible bid meeting written specifications.

PART B: Recommend acceptance of bid from Central Carting Disposal. As per the bid documents, Part B will be awarded as an “all or none” group with the “lowest and best” responsive and responsible bid meeting written specifications.

Recommend rejection of lower bids from Accurate Waste Systems and Seaside Sanitation for failure to return Addendum 1 and Addendum 2 and/or not bidding on all items in Part B as specified in bid document.

Total savings were determined by averaging all prices and deducting awarded bid.

Offers from the vendors listed herein are the only offers received timely as of the specified opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
