On January 20, 2009, official action was taken to award the above-referenced bid to Land O' Lakes, Inc. for Group A items utilizing B049 Cheese Barrels on an "all or nothing" basis for the 2009-2010 school year, and line items were awarded to East Side Entrees for Group C utilizing B077 Mozzarella, Unfrozen.

Under the terms and conditions of the bid, as new products become available they may be added to the bid. Heide Blaine, Senior Region Manager, East, Non-Commercial Foodservice; Land O Lakes, Inc. has submitted pricing for one (1) new item utilizing USDA B049 Barrel Cheese. Cathy Usenza, Office Manager, East Side Entrees has submitted pricing for three (3) new items utilizing USDA B049 Barrel Cheese or B077 Mozzarella. Fee for service and net off invoice pricing through June 30, 2010 is attached for your information.

Adding these new items will allow us a greater opportunity to utilize our USDA entitlement monies. Pricing on these products are at or below retail prices and found to be competitive.

Rick Kurtz, Director, Food and Nutrition Services is recommending to add these products to our USDA Commodity Cheese Processing bid. The estimated annual purchases are not anticipated to change the total bid award of \$175,000 using Special Revenue Funds.
