Renewal of Direct Negotiated Contract

Government Finance Officers Association (GFOA)

Third Year of Five-Year Contract

On October 2, 2007, official action was taken to approve a contract with GFOA. The contract has a term of five (5) years, and is renewable annually at the mutual agreement of the parties. The second year of the contract will expire on October 2, 2009.

At the time of contract approval, a Statement of Work for Phase I (Needs Analysis Study and Technology Plan) was also approved. Phase I has been completed, and reported to the Board. On August 5, 2008 the Board approved a Statement of Work for Phases II - IV (attached) and a purchase order has been issued for those services. The purchase order covers work to be performed during the 2009-2010 fiscal year.

At this time, we are asking for approval of the third year "umbrella" terms and conditions governing the District's relationship with GFOA. No District funds are associated with this request. The previously approved Statements of Work and associated purchase orders were funded out of District general funds. Any additional Statements of Work will be brought to the Board separately for approval. GFOA has indicated in writing (attached) that they are willing to renew for the third year, under existing terms and conditions. The District is permitted to negotiate for these professional services under DOE Rule 6A-1.012(11)(a). The third-year term will be October 3, 2009 – October 2, 2010

SUBJECT:

Statement of Work for Phases II through IV

Government Finance Officers Association (GFOA), Enterprise Resource Planning

System

On October 2, 2007, official action (attached) was taken to approve a negotiated contract and Phase I of a Statement of Work (SOW) with GFOA. GFOA conducted a District-wide needs analysis study and technology plan regarding an Enterprise Resource Planning System (ERP). The action stated that should the study indicate it is in the best interest of the District to proceed with additional steps in the ERP process, any further SOWs and associated dollar expenditures would be brought back to the Board for approval.

Attached are the results of the GFOA's needs analysis study and technology plan. The company's recommendation, also attached, is that the District proceed with Phases II through IV of the process.

The original negotiated contract, on file in Purchasing, states that additional SOWs may be added at the mutual agreement of the parties. The proposed SOW for Phases II through IV has been reviewed and approved by the Purchasing Department, Ms. Olga Swinson, Chief Finance Officer, and Mr. Bruce Baldwin, Supervisor of Information Services. As noted in the previous Board action, the District is permitted to negotiate for professional services under DOE Rule 6A-1.012(7).

The fixed fee price of \$97,050 for this project will be funded out of the District's general funds. At this time we are requesting approval of the SOW, and permission to place a purchase order in the amount of \$97,050 to GFOA. Please contact Ms. Renalia Dubose, Assistant Superintendent for Administration, or me at your earliest convenience if you have any questions or concerns.
