On July 24, 2007, official action was taken to award the above-referenced bid to Café Favorites on an all or nothing basis. This is a three-year bid, renewable annually by mutual agreement. On April 21, 2009, the third year of the contract was awarded.

Under the terms and conditions of the bid, as new products become available they may be added to the bid. Len Kretchman, President, Café Favorites has submitted pricing for three (3) new products. Food and Nutrition Services is requesting an addition of three (3) new items to the Café Favorites commodity sandwich processing bid award. The products are as follows:




