**Recommendation:**

Recommend acceptance of the bid from DeMoulin Brothers & Company as noted on the attached tabulation sheet as the lowest and best bid meeting written specifications.

**Term of Contract:**

This is a one-time purchase. Prices to remain firm for 90 days after receipt of uniforms.

**Notations and Exceptions:**

This bid is for uniforms to be utilized by Hudson High School and is part of the rotational program for uniform replacement every seven years.

Recommend rejection of lower priced bid from Fruhauf as sample uniform’s construction had deficiencies: i.e. lightweight fabric, less interlining, lesser quality trims/décor, plastic coat zipper, and inferior workmanship. In addition, they failed to provide headgear as required for evaluation purposes, which resulted in disqualification per the bid specifications. Recommend rejection of Stanbury as sample uniform’s construction had deficiencies: i.e. headgear visor weak in structure, headgear emblem was two pieces and glued together instead of a molded one piece design for stability, chin strap thin plastic, exposed staples on inside of hat body. Trousers had inferior “bagged” pocket, no bar tacking on inner pocket or zipper for reinforcement, and seams were not serged.

Offers from the vendors listed herein are the only offers received timely as of the above opening date and time. All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
